

Charles W. "Chuck" England (12/22/1944 - 1/11/2009)

Paraphrasing from the tribute from the Glimmerglass Orchestra, Chuck was a giant of a man who had a profound and positive impact on his students as a teacher and musician colleagues in the various groups with which he played and often served as musician representative within the 380-443 jurisdiction.

In late summer of 2008, after learning of his illness and being forced to relinquish his teaching, Chuck mentioned to his colleague, Local 380-443 member Megan Newman Dyer, that if he could leave his students with just one message, it would be for them to "be good to each other."

This initiative is a tribute to Chuck's musical spirit, to his "call to duty" to his profession. Ultimately, with this initiative, we are embracing the values and character expressed by Charles W. England by being good to each other and society.

- Identifying the frequency for fund distribution
- Identifying an application process for the evaluation of and awarding of funds to individual members for professional development pursuits
- Identifying the process for the selection of individuals (speakers, teachers, clinicians, etc.) or programs for presentation to or accessibility for the collective membership in support of professional growth or enhancing skills used in rendering professional musical services
- Identifying how Local 380-443 can organize its efforts to strategically carry out Local 380-443 outreach activities aimed at raising monies for this fund while simultaneously enhancing and elevating the value of our profession and unionism as a whole in the Local 380-443 jurisdiction communities through special events andarts-in-education programs.
